The Faculty of Law of the National University of Mar del Plata is an Academic Unit whose objective is teaching, research and extension, based on the principles of public, free and cogovernment universities, promoting the rule of law and respect for human rights with a with a gender perspective.

UNDERGRADUATE Academic Offer

It offers a Law degree, with a profile according to the needs of contemporary society. The graduate leaves university with the skills and training necessary to act in different fields of the social field, developing a sense of individual and collective responsibility, suitable for the formulation of new, creative and successful legal solutions, with appropriate and modern strategies, without sticking to ideas or pre-established, dogmatic and non-modifiable conceptualizations.

POSTGRADUATE Academic Offer

It also has a valuable postgraduate offer, among which are the Specializations in Criminal Law and Administrative Law and PhD in Law, categorized by the CONEAU as a B-grade Doctorate, being one of the few Faculties in Argentina to obtain that category. Additionally, its successful Doctorate program for foreigners receives students from Brazil, Colombia and Ecuador. Since 2008 it offers the undergraduate career of Auctioneer, Public Broker and Appraiser with a distance-teaching mode.

RESEARCH LINES

The Faculty of Law promotes the research activity in professors and graduates, encourages the participation of students in projects and encourages the formation of human resources. The research is carried out through several Centers of Scientific and Technological Activities (NACT): the Carlos S. Nino Research Institute, the Human Rights Research Center Alicia Moreau and several Research Groups that address different areas of law with an interdisciplinary approach.



EXTENSION LINES

The Academic Unit also develops programs and activities with community projection through interdisciplinary groups. Its main function is to stimulate a feedback between the Faculty and the Community, guaranteeing both the academic transfer and the curricular insertion of the contents extracted from the contact with the medium. Within the groups, programs, projects and volunteers, the following are highlighted: "Legal Clinic in Right to Habitat, Housing and Environmental Quality", "Promoting inclusive political participation. The right to vote of people with disabilities "," The right to know rights "," Together for more "," Teaching to Read and Write"," Commitment to preservation ","Free Legal Aid "," Citizenship Training "," Regularizing situation ", "Literacy of children and adolescents", "Academic Legal Clinic", " Legal Coaching ", "Study Techniques", "Citizenship Training and Participation" and "Consumer Law Observatory".

MOBILITY AND EXCHANGE

International exchange and mobility allow the construction of a common regional academic space and the development of the worldview of students and professionals. The Faculty sends and receives students from different countries, participating in the ESCALA Program of the Association of Universities of Montevideo Group (AUGM) and the Latin American Academic Exchange Program (PILA). In addition, it executes projects with different study centers from abroad, generated by the Unit itself, based on specific cooperation agreements, which also allow it to develop research projects jointly.
